MONITOR'S FIFTH STATUS REPORT

Pursuant to Paragraph 58 of the Consent Decree (Dkt. No. 10), the Court-appointed Monitor, Neil M. Barofsky, respectfully submits to the Court this fifth status report ("Fifth Report") concerning the monitorship of the International Union, United Automobile, Aerospace, and Agricultural Implement Workers of America (the "Union" or the "UAW").

The Monitor is filing this Fifth Report with the Court to provide an update on a subset of the results of the 2023 UAW International Officer Run-Off Election ("Run-Off Election" or "2023 Run-Off Election"), held pursuant to the unofficial results of the 2022 UAW International Officer Election ("Election" or "2022 Election"). The Official Rules for the Run-Off Election (the "Run-Off Rules") require that the Monitor announce the "unofficial" results of the Run-Off Election. Pursuant to the Run-Off Rules, an outcome has been determined for two of the Run-Off Election races. The outcome has not yet been determined, however, with respect to the International President race.

The unofficial results for the two completed races are summarized further below and attached hereto as Exhibit A. The Monitor will report to the Court the results of the Run-Off Election with respect to the International President race as soon as possible. Also at a later date, and following the process set forth in the Official Rules for the 2022 Election (the "Election Rules") and the Run-Off Rules, the Monitor will certify and report to the Court the official results of both the 2022 Election and 2023 Run-Off Election, after any election-related protests or appeals have been resolved. That report will provide additional detail on both elections, including the Monitor's oversight of the nomination process, remediation of Election Rules and Run-Off Rules violations, and the mailing, collection, and tabulation of ballots, among other topics.

Background Concerning the Vote Count

The unofficial results of the 2022 Election were reported to the Court on December 5, 2022, in the Monitor's fourth status report. As stated in that report, for certain races, a run-off was required because no Candidate secured a majority of the votes, as required under Article 10, Section 5 of the UAW Constitution.

On December 14, 2022, the Monitor promulgated the Run-Off Rules and, on January 12, 2023, the UAW's election vendor (the "Election Vendor") began mailing ballots for the Run-Off Election. To be counted, ballots were required to be received by the designated postal office in Dayton, Ohio, by 4 pm E.T. on February 28, 2023.¹ In total, over one million ballots² were mailed, and 141,548 ballots were received by the deadline.

On March 1, 2023, the Election Vendor began counting ballots in a secure facility outside of Dayton, Ohio, using largely the same process described in the Monitor's Referendum Report with respect to the 2021 Referendum, including the presence of election observers representing the candidates, the Monitor's team, and the UAW.³ By March 4, 2023, all ballots that had been deemed eligible had been counted.

² The number of ballots mailed is greater than the number of potential eligible voters under Run-Off Rule § 2-5 because, for example, some members were mailed more than one ballot if there was more than one potentially valid address for the member. This was by design, as members who had moved within the last four years or whose Referendum ballots had been returned as undeliverable, but who had a seemingly updated address (as identified through the data vendor TargetSmart or the National Change of Address database run by the U.S. Postal Service), were sent ballots to both potential addresses. In those instances, special inserts were put into the ballot packages to explain the potential for duplicates. In addition, a member's Local Union may have uploaded to the UAW's Local Union Information System ("LUIS") more than one membership record for the member, often because of variances in their name, address, or in some cases because they transferred and joined a new local, and the original record was not removed. The Election Vendor had processes in place to prevent the processing and counting of multiple ballots for the same member, as discussed in the Monitor's Referendum Report and as will be described in further detail in the Monitor's report to the Court concerning the certified election results.

The Ongoing Vote Count Relating to the Race for International President

At the time that all the eligible, unchallenged ballots had been counted, the vote differential between the two candidates for International President was only 645 votes, but the number of unresolved challenged ballots⁴ was approximately 1,600. In other words, there were more challenged ballots than the number of votes separating the two Presidential candidates. As a result, the outcome of that race could not be determined until the number of remaining unresolved challenged ballots was fewer than the votes separating the two candidates for International President. Accordingly, the outstanding challenged ballots were physically secured and the Monitor worked with the Election Vendor and the UAW to gather information needed to resolve the eligibility status of the individuals who voted these challenged ballots. The vote count was then reconvened on March 16, 2023, at the Westin Book Cadillac Detroit Hotel in Detroit, Michigan.⁵

At the continued vote count, an additional 676 ballots were tabulated and the margin between the candidates for International President decreased to 505, with approximately 600 unresolved challenged ballots remaining—meaning, the unresolved, challenged ballots still outnumbered the differential between the candidates. Accordingly, the outcome of the race for International President still could not be determined, and will continue. The Monitor will update the Court once the International President race has been resolved.

Upon preliminary review of the submission, the Monitor determined that there was no basis for such extraordinary action and denied the request. The Curry Solidarity Team submission will instead be treated as a protest in the ordinary course. *See* Run-Off Rules § 9.

Announcement of Vice President and Region 9 Race Results

Although the tabulation of the remaining votes for the race for International President remains ongoing, the unofficial results of the other races can be announced now. This is because the Run-Off results for the Vice President and Region 9 Director⁶ races each have a sufficient margin between the candidates that they do not require resolving additional challenged ballots.⁷

For these races, the Monitor oversaw the tabulation of votes received by the prescribed deadline, as well as the preparation of a document listing the vote count tally for each race. That tabulation, attached as Exhibit A to this Report, was generated by the tabulation machines used at the vote count site and reflects the compilation of the vote count as of March 4, 2023.⁸ As required by the LMRDA, the tally also breaks down the results by Local Union.⁹

That concern was previously raised with Monitor and rejected, with the agreement of the Union, on grounds that he had been a member in continuous good standing for the requisite time to run for International Office. *See* Election Rule 3-2 (explaining that the UAW determines whether a Candidate meets the constitutional criteria—including the individual's standing with the Union—to run for International Office). The Monitor will address this postelection protest in accordance with the timeline for the adjudication of election protests under the Election Rules.

As reflected in Exhibit A, two International Officers have been elected in the Run-Off Election:

Office	<u>Winner</u>
International Vice President	Chuck Browning
Region 9 Director	Daniel Vicente

Announcement of these unofficial election results does not constitute certification of the outcome.¹⁰ Instead, the Monitor will issue final certification of the results after any Run-Off Election-related protests and appeals have been resolved.¹¹ In the event that the Monitor later determines that the results of one or more races should not be certified, based on a protest or otherwise, the Monitor may take remedial action, including "ordering the rerun of any nomination or election, or any portion thereof[.]"¹²

The Consent Decree does not require the Office of Labor-Management Standards ("OLMS") or the Court to approve the results of the Run-Off Election.¹³ Instead, if the Monitor determines that any protested behavior constituted a violation of the Labor Management Reporting and Disclosure Act ("LMRDA") that impacted the outcome of the Run-Off Election, the Monitor may decline to certify one or more races and direct a re-run.¹⁴ If, however, the Monitor determines any post-election protest to be without merit, then the complainant, having exhausted their internal

remedies through their protest to the Monitor, may file a complaint with the Department of Labor under Title IV of the LMRDA, which can consider whether remedial action is appropriate.¹⁵ This protest evaluation process remains ongoing with regard to the 2022 Election, and will now commence for the two races for which unofficial results have been announced.

Notwithstanding the potential for those post-election remedial procedures, under the UAW Constitution, the Run-Off Rules, and Section 402(a) of the LMRDA, the individuals who have been elected pursuant to the unofficial Run-Off Election results will promptly be installed into office.¹⁶ Although the UAW Constitution and Run-Off Rules allow deferral of that date by seven days following the Monitor's announcement,¹⁷ to March 24, 2023, in the interests of furthering the transition of International Officers elected pursuant to the Run-Off Election as expeditiously as possible given the Union's ongoing preparations for the upcoming negotiations between the UAW and the automobile manufacturers—kicking off on March 27, 2023, with the Special Convention on Collective Bargaining—the Monitor strongly encourages the UAW to schedule that swearing in in the next few days and well before the March 24, 2023 deadline.
