

2022 UAW International Officer Election
Credentialed Representative Form
[Election Rules, Section 4-2]

Section 4 of the Election Rules governs campaigning and access related to and in connection with the 2022 UAW International Officer Election. The Rules provide detailed guidance regarding permissible and prohibited campaigning and access for Candidates and Slates. As set forth in Section 4-2 of the Rules, each Candidate or Slate may authorize up to five (5) members in good standing to serve as their Credentialed Representative for the purpose of acting on behalf of the Candidate or Slate when the Candidate or Slate is not present or is otherwise unable to do so for themselves. A Credentialed Representative have the same rights as are permitted the Candidate and Slate in Section 4 of the Rules. The Candidate or Slate **MUST** submit this Credentialed Representative Form to provide authorization to one or more Credentialed Representatives. Please read the Explanation and Instructions below. Then, turn to Page 3 to complete the Credentialed Representative Form.

EXPLANATION AND INSTRUCTIONS

Explanation

As set forth in Section 4 of the Official Rules for the 2022 International Officer Election of the UAW (the “Rules”), Candidates for International Office will have certain rights of access to enable them to conduct an effective election campaign. **Each Candidate or Slate may authorize up to five (5) members in good standing to serve as their Credentialed Representative** for the purpose of acting on behalf of the Candidate or Slate when the Candidate or Slate is not present or is otherwise unable to do so for themselves. A Credentialed Representative shall have the same rights as are permitted the Candidate and Slate in Section 4 of the Rules. Further, as set forth in Section 8 of the Rules, a Credentialed Representative may serve as the Treasurer of a Slate of Candidates’ campaign.

Instructions

The Credentialed Representative Form below must be filled out completely, and must be either typed or handwritten legibly in blue or black ink. **A Candidate or Slate may complete one Credentialed Representative Form for up to the maximum five (5) Credentialed Representatives** for the Candidate or Slate. If initially fewer than five (5) Credentialed Representatives are designated and a Candidate or Slate wishes to add additional Credentialed Representatives, they may do so by submitting a new Credentialed Representative Form designating the additional Credentialed Representatives (for a maximum total of five (5)).

***USA v. UAW, No. 20-13293 (E.D. Mich.)
Credentialed Representative Form – May 11, 2022***

Using the below Credentialed Representative Form (Declaration), a Candidate or Slate Treasurer shall authorize member(s) in good standing to serve as Credentialed Representative(s) of the Candidate or Slate. The Credentialed Representative shall certify that they are a member in good standing and agree to serve as a Credentialed Representative for the Candidate or Slate.

The Credentialed Representative Form (Declaration) must be signed by the Candidate or the Slate treasurer and by each desired Credentialed Representative(s). Signatures may be handwritten or electronic. Additionally, filing of multiple copies of an identical Credentialed Representative Form (Declaration), signed in counterpart by the Candidate or the Slate treasurer, and by the Credentialed Representative(s), shall be considered a proper submission.
