

**2022 UAW International Officer Election**  
**Slate Declaration Form**  
**[Election Rules, Section 6-3]**

The term “Slate” means any grouping by mutual consent of two or more Candidates. All Candidates desiring to create or join a Slate or Slates **MUST** use this form. Please read the Explanation and Instructions below. Then, turn to Page 3 to complete the Declaration of Affiliation with Slate. **If a Candidate seeks affiliation with multiple Slates, the separate “Multiple Slate Affiliation Declaration Form” must also be completed.**

**EXPLANATION AND INSTRUCTIONS**

**Explanation**

As set forth in Section 6 of the Official Rules for the 2022 International Officer Election of the UAW (the “Rules”), each Bona Fide Candidate for International Office shall have the right to seek nomination, be nominated, campaign, and appear on the ballot as a member of a Slate of Candidates.

No Candidate shall be compelled to run as a member of a Slate. To form a Slate, there shall be mutual consent between and among all Candidates running on the Slate. Such mutual consent shall be evidenced by the signing of the below Declaration by all members of the Slate, providing the position that each Candidate seeks and the name of the Slate to be formed.

The number of Slate members shall not exceed a single Candidate for each open office (1 for International President, 1 for International Secretary-Treasurer, 3 for International Vice President, and 1 for each of the 9 Regional Director positions, totaling 14 maximum Candidates).

Slate Declaration Forms for the Election shall be submitted to the Monitor at the earliest possible date, but in no event later than **September 1, 2022**. Amended declarations may be submitted adding additional Candidates to the Slate, provided that the deadline of September 1, 2022 is met.

The Slate Declaration Form shall include the designation of a treasurer for the Slate who will be the point of contact for the Slate and who shall have primary responsibility for any financial disclosures being submitted on behalf of the Slate. The Slate treasurer must be a member of the Union, but need not be a Candidate.

Should one or more members of a Slate be found ineligible to run, such ineligibility shall not affect the eligibility of remaining members of the Slate.

Since unanimity is required to be on a Slate, if a Slate of Candidates wishes to remove one or more previously-declared Candidates from the Slate, they may do so at any time by emailing the Monitor at [UAWMonitor-Election@jenner.com](mailto:UAWMonitor-Election@jenner.com) and copying all other members of the Slate.

Similarly, if a member of a Slate wishes to remove themselves from the Slate, they may do so in the same fashion. If a Slate intends to remove a Candidate from its roster, or a Candidate intends to remove themselves from a Slate, they should do so no later than September 1, 2022. All Slate designations need to be finalized no later than September 1, 2022. After that date, it should be presumed that the Ballot will reflect the Slate designations.

A Candidate may associate themselves with more than one Slate, but they must provide notice that they intend to appear on multiple Slates and receive written consent from each of the member of each Slate with which they plan to associate that they agree the Candidate can do so. A separate “Multiple Slate Affiliation Declaration Form” accompanies this Slate Declaration Form and is intended for Candidates who seek to affiliate with more than one Slate in the 2022 UAW International Officer Election. All Candidates desiring to affiliate with more than one Slate **MUST** use that separate form to attest and evidence that they have provided notice and received written consent from each member of each Slate with which they plan to associate. They also assume all the responsibilities for any and all Slates of which they are a member.

**Instructions**

The Slate Declaration Form below must be filled out completely, and must be either typed or handwritten legibly in blue or black ink. The names of all members of the Slate must be entered **before** any signatures are entered. To expand a previously declared Slate, a new Slate Declaration Form naming all Candidates on the expanded Slate must be signed by each member of the Slate.

The Declaration must be signed by each Candidate, and by the Slate treasurer. Signatures may be handwritten or electronic. Additionally, filing of multiple copies of an identical Slate Declaration Form, signed in counterpart by all members of the Slate, and by the Slate treasurer, shall be considered a proper submission.
